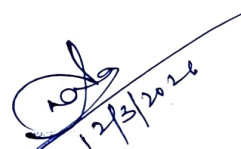

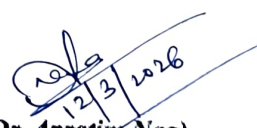

With due respect, I would like to inform you that the District Administration is required to conduct training programmes for Polling Personnel in connection with the forthcoming General Election to Assam Legislative Assembly, 2026. For the said purpose, a number of Higher Secondary Schools and Colleges are proposed to be utilized as training venues.

It has been learnt that the schedule of the HS 1st Year Examination, 2026 may coincide with the proposed training dates, which are 17<sup>th</sup> March/2026 to 20<sup>th</sup> March/2026, 27<sup>th</sup> March/2026 to 30<sup>th</sup> March/2026 and 01<sup>st</sup> April/2026 to 04<sup>th</sup> April/2026.
