**NOTICE REGARDING ADMISSION OF SHORTLISTED CANDIDATES FOR  
FYIMP PROGRAMMES (ACADEMIC SESSION 2026-27)**

In continuation of the Admission Notice issued earlier and pursuant to the admission schedule notified by the Directorate of Higher Education (DHE), Assam, it is hereby informed to all candidates shortlisted in the Merit Lists for admission into the Five-Year Integrated Master's Programmes (FYIMP) under Gurucharan University, Silchar that the admission process shall be conducted strictly as per the schedule and procedure detailed below.

Candidates and their guardians are advised to read the instructions carefully and ensure compliance with all requirements for smooth completion of admission formalities.

**REPORTING AT DEPARTMENT**

All shortlisted candidates shall report to their respective Departments between **10:00 AM and 3:00 PM** on the date allotted for admission.

The Department concerned shall serve as the designated venue for completion of all pre-admission formalities, including:

- Verification of original marksheets, certificates and testimonials;
- Verification of caste certificates, Non-Creamy Layer Certificates, Income Certificates and other supporting documents, wherever applicable;
- Verification of reservation and fee waiver claims;
- Academic counselling regarding programme structure and subject combinations;
- Selection and allotment of AEC, MDC, SEC and VAC courses, subject to availability and University regulations.

Candidates are advised to bring all original documents along with self-attested photocopies for verification.

**FEE WAIVER SCHEME CANDIDATES**

1. Candidates seeking admission under the Fee Waiver Scheme shall be scrutinized by the competent authority on the basis of the prescribed eligibility criteria and supporting documents.
2. Candidates found eligible under the Fee Waiver Scheme shall be granted admission provisionally and shall not be required to proceed for payment of admission fees. Such candidates may leave the venue after completion of departmental counselling and document verification formalities, subject to further approval by the University wherever necessary.

**CANDIDATES UNDER PAID ADMISSION CATEGORY**

1. Candidates not covered under the Fee Waiver Scheme shall, after completion of departmental verification and counselling, proceed to the designated Admission Payment Counters located at the ground floor of **New Commerce Building (RUSA Building; adjacent to the Department of Commerce)** for payment of admission fees.
2. It may be noted that payment of admission fees shall be accepted only at the designated University payment counters established for this purpose.

**MODE OF PAYMENT**

Admission fees shall be accepted **STRICTLY THROUGH ONLINE MODE ONLY**.

Students may make payment through:

- UPI/QR Code
- Debit Card
- Credit Card
- Net Banking
- Other authorized digital payment facilities provided by the University

**Cash payment, cheque, demand draft or any other offline mode of payment shall not be accepted under any circumstances.**

Candidates are therefore advised to carry a mobile phone, bank card or other appropriate means to facilitate digital payment on the day of admission.

**IMPORTANT INSTRUCTIONS**

1. Admission shall be purely provisional until verification of all documents and fulfilment of eligibility conditions.
2. Any discrepancy, suppression of facts or submission of false documents shall result in cancellation of admission at any stage.
3. Reserved category candidates must produce valid supporting documents in original.
4. Candidates must remain present personally during counselling and admission formalities.
5. All admissions shall be governed by the applicable rules, regulations and guidelines of the Government of Assam, DHE Assam and Gurucharan University.
6. Refund of admission fees shall be processed only after completion of the entire admission process, in accordance with Government norms and DHE guidelines. Refund and cancellation of admission shall be allowed only within the timeline prescribed by the Directorate of Higher Education (DHE), Assam.
7. Candidates are advised to keep themselves updated by regularly visiting the official website of Gurucharan University, Silchar.

All concerned candidates and guardians are requested to adhere strictly to the above instructions for smooth and timely completion of the admission process.
