Notice regarding FYIMP Final Spot Admission

(Academic Session 2026–2027)

Considering a **very few** seats are still remaining vacant, the FYIMP Final Spot Admission will be held from **4th–7th August, 2026**.

Students can apply to avail the vacant seats through **SAMARTH portal** and submit the hardcopy of their application to the respective department from **10 am – 12 noon** on **4th, 5th, 6th & 7th August, 2026**. The candidates will be considered based on the vacant seats available. The selection of the candidates will be strictly on merit following the reservation criteria.

Guidelines for the FYIMP Final Spot Admission

1. The FYIMP Final Spot Admission will be held from **4–7 August 2026** against the vacant seats available after the previous rounds of admission.
2. Only those candidates who are duly registered in the **Assam State Higher Education Admission Portal (SAMARTH)** are eligible to participate in the spot admission process. Candidates who have not applied earlier may submit fresh applications through the SAMARTH Portal.
3. Candidates must be physically present in the respective department with all original documents for verification during the Spot Admission process.
4. The hard copies of the application forms will be received by each department from **10 am – 12 noon** on **4th, 5th, 6th and 7th August 2026**. The forms should be of **Gurucharan University** and the respective DSC.
5. At **12 noon**, the receipt of forms will be closed and the merit list will be prepared following the reservation quota.
6. The merit list will be displayed in the respective departmental notice board at **1:30 pm**, after due verification in the **IQAC** meeting hall. A copy of the merit list needs to be submitted to the Chairperson, Admission Committee.
7. The counselling, academic and document scrutiny of the application forms of the selected candidates will be done by the respective department.
8. After counselling and scrutiny of the application forms, it will be approved by the respective **HODs** following the same procedure of the earlier FYIMP admission rounds. The

candidates will then proceed for fee payment in the **Admission Fee Payment Counter** located at the **Ground Floor of New Commerce Building** for the payment of admission fees through **cashless mode**.

- Other authorized digital payment facilities provided by the University

11. Cash payment, cheque payment, demand draft or any other offline mode of payment shall not be accepted under any circumstances. Candidates are therefore informed to carry a mobile phone or any other appropriate means to facilitate digital payment on the date of admission.
