NOTICE REGARDING SPOT ADMISSION OF THE TWO-YEAR MASTER'S PROGRAMME

(M.A., M.Sc., M.Com and M.B.A.)

The spot admission for the Two-year Master's Programme (M.A., M.Sc., M.Com and M.B.A.) will be held from 12–14 August 2026 as per the DHE timeline.

Students can apply to avail the vacant seats through SAMARTH portal and submit the hardcopy of their application to the respective departments on 12th, 13th and 14th August from 10 AM–12 noon each day. The selection of the candidates will be based on the vacant seats available. The selection of the candidates will strictly be on merit basis. The reservation criteria of the GOA/GOI will be followed.

The Department of Business Administration will, however, receive applications only on 12th August from 10 AM–12 noon. This will be followed by departmental test, group discussion and personal interview. The merit list will be prepared based on UG score, departmental test, group discussion and personal interview. Students interested to study M.B.A. can go through the detailed notice dated 10th Aug. 2026.

Guidelines for the Spot Admission of the Two-year Master's Programme

1. The Spot Admission for the Two-year Master's Programme will be held from 12–14 August 2026, against the vacant seats available after the previous round of admission.
2. The hardcopy of the application forms will be received by each department from 10 AM–12 noon on 12th, 13th and 14th August 2026. The Business Administration department will follow the procedure as notified on 10th August 2026.
3. At 12 noon, the receipt of the application forms will be closed and the merit list will be prepared based on the vacant seats available following the reservation quota.
4. The merit list will be displayed in the respective notice board at 1:30 p.m., after due verification in the IQAC meeting room. A copy of the merit list needs to be submitted to the Chairperson, Admission Committee.
5. The counselling of the selected candidates, academic scrutiny and document verification will be done in the respective departments.
6. After counselling and scrutiny of the application forms, it will be approved by the respective HODs following the same procedure as done in the earlier rounds.
7. The selected candidates will then proceed for fee payment in the Admission Fee Payment Counter
