It is notified for information of all concerned that the link for online submission of Re-Check/Re-evaluation form for FYUGP Even Semester Examination, May, 2026 will be opened from **19-08-2026** and remains open till **25-08-2026 up to 11.59PM** for the students. Interested students will login to <https://ausexamination.ac.in/nep> by clicking **STUDENTS LOG IN**, using Registration No. as user ID and password as was created at the time of registration process. The students are required to take printout of filled in application and the payment receipt and submit to the concerned college along with the Grade Card latest by 28.08.2026.

All the colleges are requested to complete verification of Re-evaluation form and approve the same within **29-08-2026**. The last date of submission of the hard copies along with the necessary statement by the college to the Examination Branch is **18-09-2026**.

The term and condition for Re-Evaluation are as below:

1. The Payment of Re-Check (Scrutiny)/Re-evaluation fees will be through payment gateway (Grade Card fee @ Rs. 50/-, Re-evaluation fee @ Rs. 200/- per paper, Re-Check (Scrutiny) fee @ Rs. 100/- per paper).
2. The facility of Re-evaluation/ Re-Check (Scrutiny) is not applicable to practical examination papers.
3. Re-checking /scrutiny of answer scripts of theory papers of any ESE may be allowed maximum 3 papers in each semester by the University irrespective of grade obtained. In re-checking/scrutiny of marks, only posting and totalling of marks shall be checked.
4. The score after re-evaluation shall supersede the earlier score i.e. the re-evaluated result is final even if he/she becomes Fail/Pass after re-evaluation.
